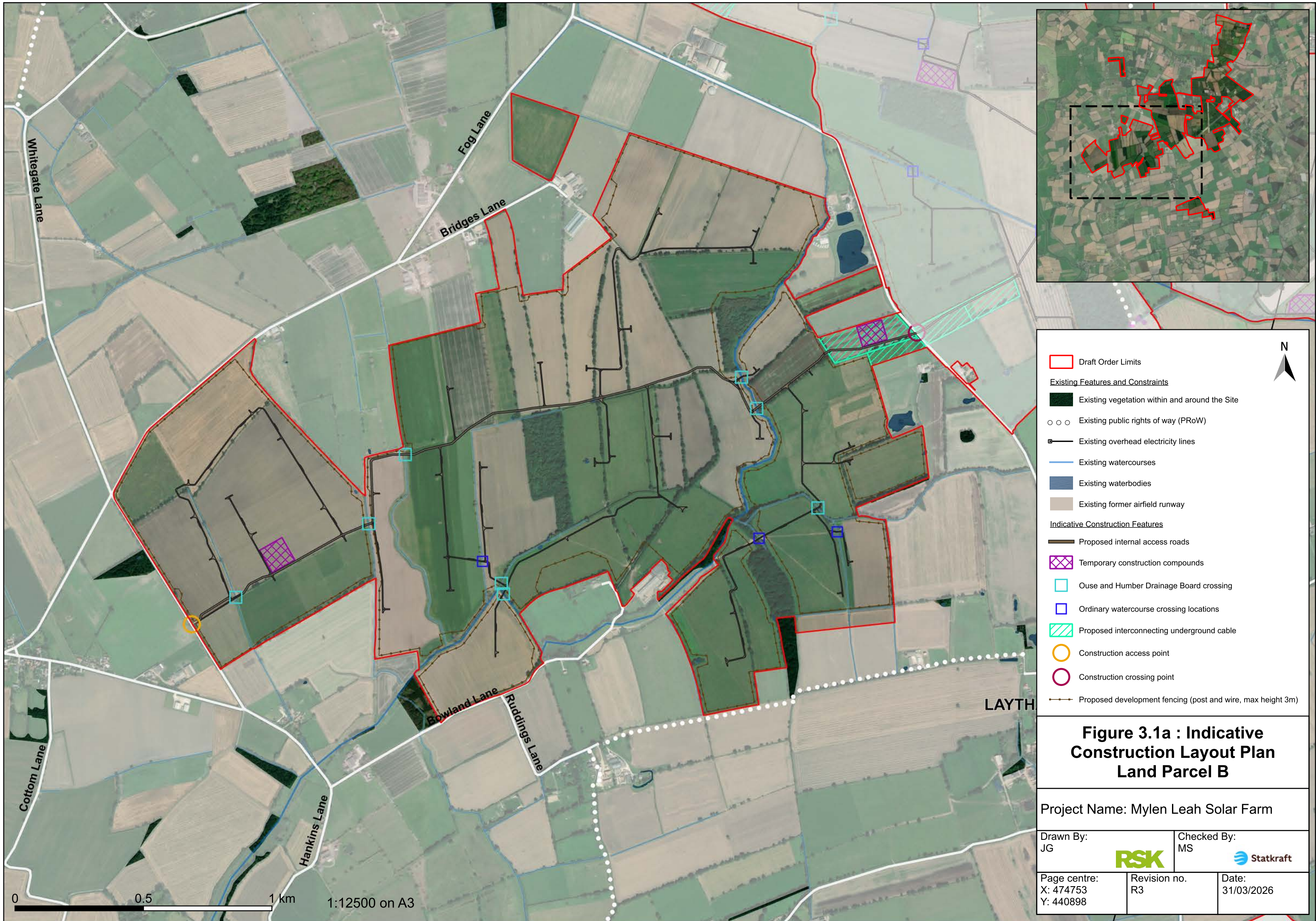
Figure 3.1 : Indicative Construction Layout and Access Plan

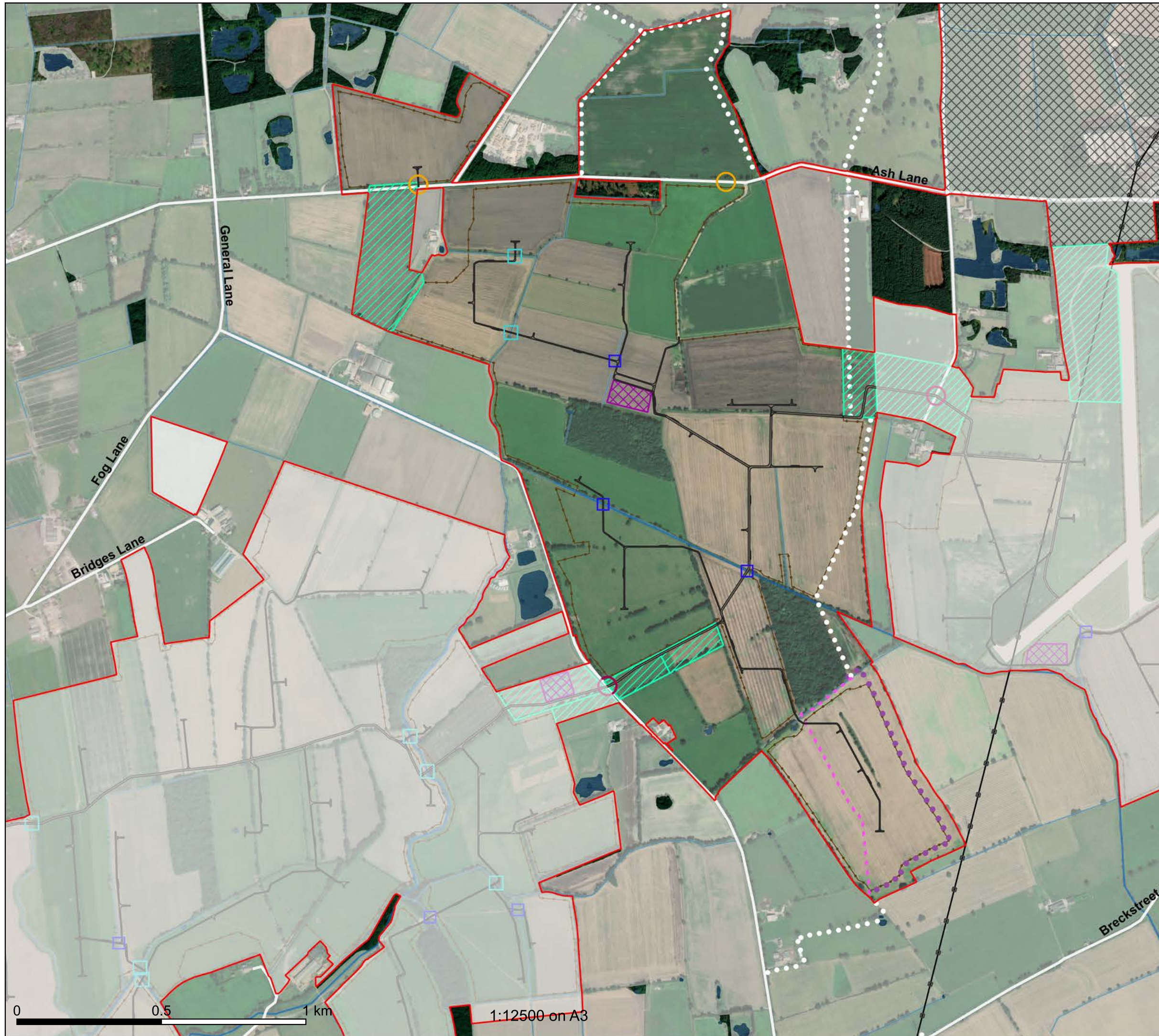

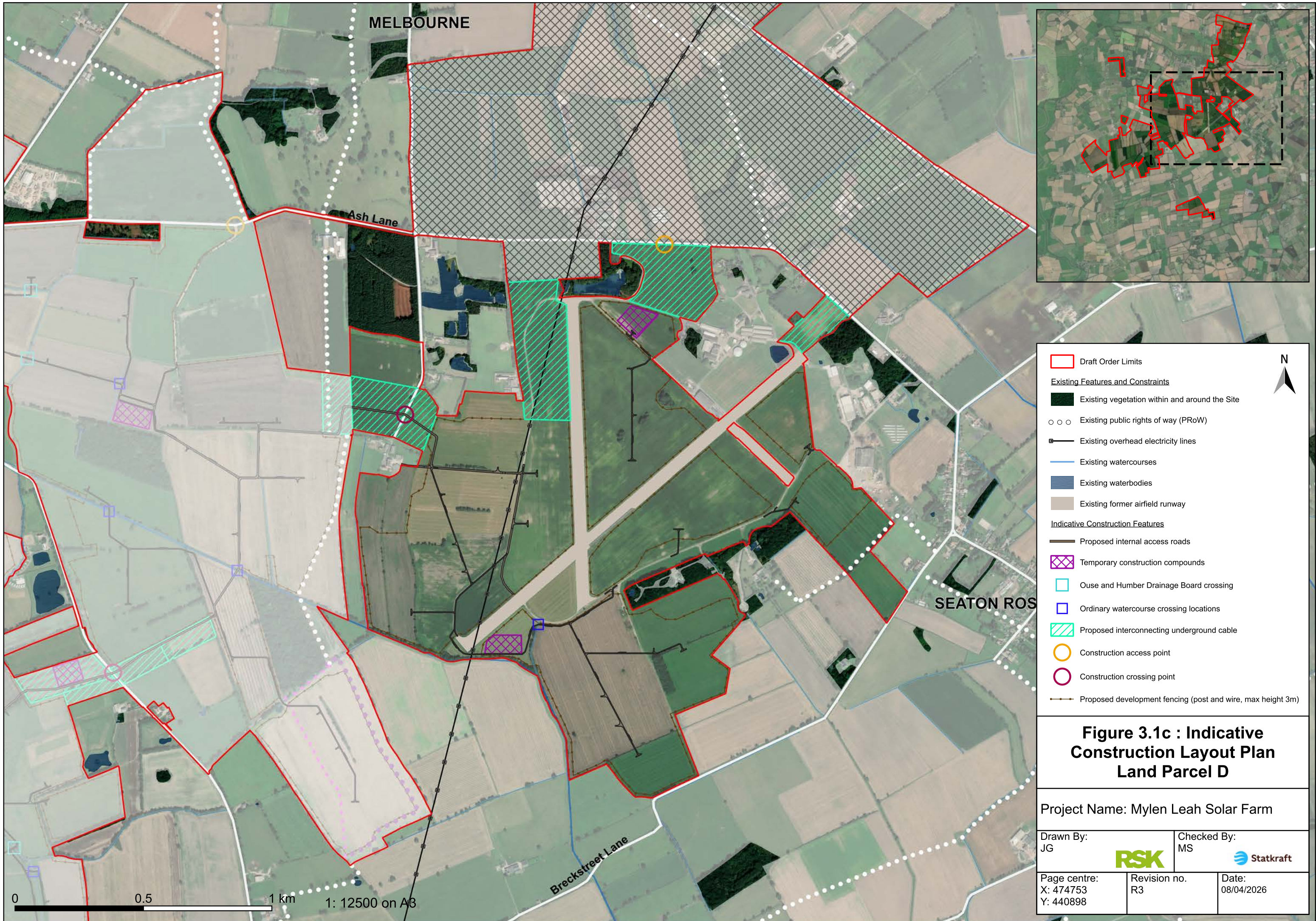
