# ECU00004851 - Section 36 Application for Carn Fearna Wind Farm

Electricity Act 1989 Town and Country Planning (Scotland) Act 1997 The Electricity Works (Environmental Impact Assessment) (Scotland) Regulations 2017

Carn Fearna Wind Farm Limited, a wholly owned subsidiary of Statkraft UK Limited (Statkraft) is applying for consent under Section 36 of the Electricity Act 1989 and for a direction that planning permission be deemed to be granted under section 57(2) of the Town and Country Planning (Scotland) Act 1997 to install and operate a wind farm and associated ancillary infrastructure (the Carn Fearna Wind Farm) on land north-east of the village of Garve in Ross-shire. The wind farm site is centred on Ordnance Survey National Grid Reference (NGR) E-242260, N-862627 and covers an area of approximately 1,003 hectares (ha) in total within the Highland Council (THC) area (within the Garve and District and Strathpeffer Community Council areas).

The installed capacity of the proposed generating station would be over 50 MW and would comprise of nine wind turbines which would be up to 200 m to blade tip in an upright position for five of the turbines (T1, T2, T3, T4 and T8), and up to 180 m for the remaining four turbines (T5, T6, T7 and T9). Consent is sought for an operational lifespan of the Proposed Development of up to 50 years.
