NatureScot Visualisations Clarification

Dear Debbie,

I am writing to you to clarify an element of the application submission following a query that has been raised by a member of the public directly with Statkraft. The query concerned the extent of information shown in the NatureScot compliant visualisations within the Loch Liath Wind Farm Environmental Impact Assessment Report (EIA Report). The visualisations (Figures 6.14-6.36, as listed at Appendix A to this letter) include cumulative wirelines with legends which reference design/scoping schemes. However whilst these schemes are shown within the legend, they are not shown within the content of the visualisations. A similar point also applies to the accompanying viewpoint map pages associated with the cumulative wirelines.


To clarify, as set out within the Loch Liath Scoping Report (Dec 2020), the methodology proposed for the cumulative landscape and visual impact assessment proposed to include other wind farm developments which are operational, under construction, consented or the subject of a valid application submitted to the relevant authorities, but not yet determined. Wind farms at design/scoping stage were <u>not</u> proposed to be included in the cumulative assessment (see Scoping Report para 2.19). In the Scoping Opinion (dated 30 April 2021) the Scottish Ministers did not disagree with this proposal.

This same methodological approach to the assessment of cumulative effects in the landscape and visual impact assessment is set out within Chapter 6 and Appendix 6.1 of the EIA Report (April 2023). Paragraph 6.80 of the LVIA (Chapter 6) notes that *"Proposals that had not yet progressed beyond Scoping stage were not considered within the assessment."* Schemes included in the cumulative assessment (and shown in cumulative wirelines and **Figure 6.7b**) are detailed in Table 6.8 of **Chapter 6**, which excludes the design/scoping schemes.

The final list of wind farms included in the cumulative assessment was agreed with NatureScot and the Highland Council in October 2022 (see Table 6.8 of Chapter 6). No design/scoping stage wind farms were specifically requested for inclusion by NatureScot or the Highland Council.

Given the early stage and associated uncertainty of these proposals, schemes which have not yet progressed beyond scoping are not considered within the Cumulative Landscape and Visual Assessment*"

Unfortunately, the standard legend was not updated when producing the visualisations referred to above (and in Appendix A) and so the reference to schemes at design/scoping has been retained even though it was not intended for them to be captured. In essence, this is a typographical error and the assessment is unaffected by the misprint in the legend.

I trust the above clarifies that design/scoping schemes were never intended to be shown in the cumulative wirelines visualisations and the visualisations should, be reviewed alongside the methodology text set out in **Chapter 6** of the EIA Report, and in particular the list of schemes included in the cumulative assessment detailed in Table 6.8.
